

AMENDMENT SIX TO GENERAL LICENSE AGREEMENT

This Amendment ("Amendment") dated May 1st, 2014 to the License Agreement Walter de Gruyter, Inc. dated June 1, 2011 ("Agreement") and last amended April 25, 2014 is by and between Walter de Gruyter, Inc., hereinafter referred to as "DeG" and The Regents of the University of California, hereinafter referred to as "Licensee" on behalf of the California Digital Library.

WHEREAS, the parties hereto previously entered into an Agreement, dated June 11, 2011 and the parties hereto desire to amend certain terms of the Agreement;

NOW, THEREFORE, in consideration of the agreements and obligations set forth in the Agreement and this Amendment, and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties hereto agree as follows:

- 1. **Modifications to the Agreement.** The Agreement is hereby modified to include De Gruyter eBooks option for University of California, San Diego as per Schedule 1.
- 2. Legal Effect. Except as set for the herein, all of the terms and conditions of the Agreement shall remain in full force and effect. In the event of conflicting or additive terms between the terms of the Agreement and this Amendment, the terms of this Amendment shall apply in lieu of those in the Agreement. Any capitalized term used in this Amendment shall have the meaning given thereto in the Agreement.
