

AMENDMENT NO. 14

Amendment No. 14, dated 11 February 2021 (the "Amendment") to the IEEE eBooks Agreement (Academic) dated 6 July 2011 (the "Agreement") between **The Institute of Electrical and Electronics Engineers, Incorporated ("IEEE")**, a New York not-for-profit corporation, and **The Regents of the University of California on behalf of the California Digital Library** (the "Licensee" and, together with IEEE, the "Parties"). Capitalized terms used herein and not otherwise defined shall have the meaning given to them in the Agreement.

WHEREAS, the Parties desire to enter into this Amendment to the Agreement;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties hereby agree as follows:

1. Add "Artech House - Publishers eBooks Library, Front List/Complete Library" under Section 1.d., as a Licensed Product available to the following Participating Member Institutions and as follows:

Participating Member Institutions

2. UC Berkeley
3. UC Irvine
4. UCLA
5. Lawrence Berkeley National Laboratory (LBNL)

- **2021 Frontlist - Davis & Berkeley Campus: \$ [REDACTED] USD**

Davis and Berkeley receive dual access to the Artech House backfiles with the 2021 Frontlist purchase. (UCD backfile to 2016/ UCB complete backfiles).

- **2021 Complete Library – UCLA & UC Irvine Campus: \$ [REDACTED] USD**

UCLA & Irvine purchase access to the complete library (includes 2021 Frontlist with complete backlist)

- **2021 Frontlist - Lawrence Berkeley National Lab (LBNL): \$ [REDACTED] USD**

LBNL receives dual access to the Artech House backfiles with the 2021 Frontlist purchase. (LBNL complete backfile).

2. Pursuant to Section 2, the Supplemental Front List License Fees for Artech House eBooks – Frontlist 2021 and Complete Library total due shall be [REDACTED] US dollars (\$ [REDACTED]). 2021 pricing valid for University of California campuses as listed above, purchased on one invoice via the CDL. *Pricing discounts valid with CDL group purchase on one invoice via the CDL.

- 3. This Amendment is governed by the Agreement. The terms of this Amendment supersede provisions in the Agreement only to the extent that the terms of this Amendment and the Agreement expressly conflict. However, nothing in this Amendment should be interpreted as invalidating the Agreement, and provisions of the Agreement will continue to govern relations between the Parties insofar as they do not expressly conflict with this Amendment.
- 4. This Amendment may be executed in counterparts and by facsimile, each of which shall be deemed an original and both of which shall constitute one and the same document.
