

**SCHEDULE A-2

Licensee: *Regents of the Univ. of California Digital Library* on behalf of itself and as Agent for the Institutions Identified in Schedules B-1 to B-() Attached Hereto

I. General Terms

As indicated in Section II of this Schedule, Licensee wishes to subscribe to Current Issues of journals available in JSTOR through the Current Scholarship Program, a collaborative effort among publishers and JSTOR to make current and historical content available on a single, integrated platform, to provide a single point for librarians and end users around to world to license and access this content, and to ensure this content's long-term preservation.

Participation shall be subject to the Institutional Participation Agreement, the Terms and Conditions of Use, available at <http://www.jstor.org/page/info/about/policies/terms.jsp>, and Licensee's payment of applicable fees. JSTOR shall make the Current Issues of journals selected available online in digital form¹ to Licensee and its Authorized Users within ten (10) days of when this Schedule is properly completed, signed, and received by JSTOR and the subscriptions selected are publicly available, provided, however, that appropriate authentication and authorization information shall have been provided to JSTOR.

Subscription and Participation Options

Licensee may subscribe to Current Issues titles (1) as single title subscriptions, available on a calendar year or rolling basis; (2) as part of Current Collections (for example, Arts & Sciences I – Current), available on a calendar year basis; or (3) as otherwise agreed upon by the parties. Current Issues subscriptions include all issues of a journal published online from the start date of the subscription until one year later (or longer if mutually agreed upon). In addition, Current Issues subscriptions include issues of the journal published online back to the Digital Availability Date.² Information concerning the content in Current Collections is available on request to JSTOR or at <http://support.jstor.org/esp/collections/> and <http://support.jstor.org/esp/titles/>.

Access to the full run of a title, going back to volume 1, issue 1, is available (1) on a single title basis for Current Issues subscribers, or (2) in conjunction with JSTOR's Archival Collections, the terms of which are covered elsewhere in this Schedule A.

Pricing and Payment Terms

Fees for Current Issues subscriptions are set by the Publisher on a title-by-title basis. Current Collections are priced at the sum of these fees. These fees may be tiered according to JSTOR's classification scheme or flat. Fees for single title archives as well as Archival Collections are tiered and are set by JSTOR.

¹ In some instances where Licensee is subscribing to current issues through the Current Scholarship Program, it also may wish to subscribe to the print version of such title. Licensee can indicate this request in the Subscription Order Form. JSTOR shall forward any such subscription request to the applicable publisher, which shall be solely responsible for print order fulfillment, delivery, and customer service. Title to any print volumes ordered in this way shall pass to Licensee once shipped from the publisher.

² The "Digital Availability Date" is the year when the title initially was published online in digital format, subject to exceptions as determined by the publisher and JSTOR. For purposes of clarification, the Digital Availability Date does not refer to when digitized versions of print issues became available through a JSTOR archival product, but rather refers to when "born digital" versions of the title became available. Information concerning the Digital Availability Date for each title is available at <http://support.jstor.org/esp/titles/>

All payments provided for in this Schedule shall be paid in United States Dollars, in an amount to be calculated and established at the time payment is due such that after deduction for any taxes, assessments or charges levied, assessed or imposed which Licensee, JSTOR or any other party shall be required to pay or withhold in respect to or calculated with reference to such amount, the remainder actually received by, and due and payable to JSTOR, shall be the amounts specified in this Schedule. Any payments made more than thirty (30) days after they are due and payable may be subject to a 10% annual interest charge, to the extent allowable, or termination of access. If applicable, Licensee shall provide to JSTOR its VAT registration number. If Licensee is unable to provide a VAT registration number, JSTOR reserves the right, at its sole discretion, to pass through to Licensee, in addition to the Archive Capital Fee(s) and the Annual Access Fee(s) noted above, the cost of VAT it may be obligated to collect in connection with this Schedule under applicable EU Directives.

Term and Termination

Unless otherwise agreed upon, this Schedule shall continue in effect for one (1) year from the first day of the calendar year that follows the Schedule Date, or as applicable, for an additional year or years in the case of Current Issues subscriptions that extend beyond the calendar year following the Schedule Date (the "Initial Term of Current Issues Schedule"), and assuming the availability of funding, will renew for successive one (1) year terms, or as applicable, such additional calendar year terms as cover the subscription period, by the payment of the annual invoice unless earlier terminated by either party by written notice not less than ninety (90) days prior to the end of the then-current term.

In the event that either party believes that the other materially has breached any obligations under the Agreement, including this Schedule, or if (a) JSTOR believes that Licensee has exceeded the scope of the License, or (b) any payment due JSTOR pursuant to Schedule A, as attached hereto, or this Schedule has not been received, such party shall so notify the breaching party in writing. The breaching party shall have thirty (30) days from the receipt of notice to cure the alleged breach and to notify the non-breaching party in writing that cure has been effected. If the breach is not cured within the thirty (30) day period, the non-breaching party shall have the right to suspend or terminate the Agreement or this Schedule without further notice. In addition, JSTOR may terminate Licensee's access to the Archive immediately if, (a) in JSTOR's reasonable opinion, the cumulative effect of violations of the Terms and Conditions of Use by Authorized Users justifies such termination, or (b) Licensee enters into a bankruptcy or change of ownership.

Post-Cancellation Access

Access to Current Issues shall be available to Institutions following the Institution's cancellation or non-renewal of a Subscription to the applicable Publication ("Post Cancellation Access"). The scope of an Institution's Post Cancellation Access is as set forth in JSTOR's Terms and Conditions of Use, available at <http://www.jstor.org/page/info/about/policies/terms.jsp>, which terms for Post-Cancellation Access shall supersede any and all previous post-cancellation language set forth in prior agreements between Licensee and JSTOR.
