WHEREAS, PRINCETON has developed a proprietary database entitled THE INDEX OF CHRISTIAN ART™, hereinafter referred to as "INDEX", and LICENSEE desires to obtain and PRINCETON desires to grant a License to use same.

LICENSEE AND PRINCETON HEREBY AGREE TO THE FOLLOWING:

I. LICENSE

This License is made by and between The Trustees of Princeton University ("PRINCETON") and ("LICENSEE"), effective on (the "Effective Date"). LICENSEE shall hereby receive a non-exclusive, non-transferable, non-commercial site license allowing the right use, for internal research purposes, the INDEX furnished by PRINCETON subject to the terms and conditions of this License.

II. LIMITATION OF LICENSE AND RESTRICTIONS

A. Licensee may use the INDEX for internal education and research purposes and any use and copying shall be in keeping with the fair use provision of Section 107 of the Copyright Act of the United States. LICENSEE may not translate, display the INDEX, in whole or in part, unless expressly authorized in this License.

B. This LICENSE is non-assignable, and is renewable on a yearly basis.

C. LICENSEE agrees that the INDEX is for LICENSEE'S sole and exclusive use. LICENSEE may not disclose, sell, assign, license, or otherwise distribute the INDEX to any third-party without the prior written consent of PRINCETON. LICENSEE agrees to secure and protect the INDEX and any copies in a manner consistent with the maintenance of PRINCETON'S rights in the INDEX and to take appropriate action by instruction or agreement with its employees who are permitted access to

the INDEX in order to satisfy LICENSEE'S obligations under this License.

- D. LICENSEE shall not modify the INDEX under this LICENSE. NO modifications requested by LICENSEE shall be carried out by PRINCETON.
- E. Except as required under Section IV, Paragraph B. of this License, LICENSEE shall not use the name or names of Princeton University, or any adaptation, abbreviation or derivative, whether oral or written, without the prior written permission of Princeton University.

### III. CONSIDERATION

LICENSEE agrees to pay PRINCETON the fee of [Text deleted] for the INDEX as specified in attached Price List. Payment shall be made by check in U.S. currency, paid in advance to the order of "Trustees of Princeton University", and sent, along with both signed copies of this agreement to the attention of [Text deleted] at the above address.

### IV. TITLE AND OWNERSHIP

- A. Sole title and ownership rights to the INDEX shall remain with PRINCETON.
- B. The data provided by the INDEX is original research material. Permission for use of these materials has been obtained by PRINCETON.
- C. LICENSEE acknowledges PRINCETON'S proprietary rights in the INDEX and agrees to reproduce all copyright notices supplied by PRINCETON on all copies of the INDEX.
- D. LICENSEE shall credit the INDEX in any publications arising from research for which the INDEX is used.

### V. DISCLAIMER OF WARRANTY

- A. INDEX is provided "As Is" without warranty of any kind, either express or implied, including without limitation implied warranties of merchantability and fitness for a particular purpose. PRINCETON does not warrant that the functions contained in the INDEX will meet the LICENSEE'S requirements or that the operation will be uninterrupted or error free. The LICENSOR shall, however, exert reasonable efforts to ensure that the INDEX is available at all times.



- B. LICENSEE fully indemnifies PRINCETON, its trustees, directors, officers, employees, agents, and affiliates for damages from LICENSEE'S use of INDEX, but only in proportion to and to the extent that such damages are due to the negligence or willful acts or omissions of LICENSEE, its officers, employees and agents.

In any suit between the parties, neither party shall be liable for special, indirect, incidental, or consequential damages, even if it has been or is hereafter advised of the possibility of such damages from LICENSEE'S use of INDEX.

- C. It is understood that PRINCETON has no obligation to provide maintenance, support, nor update services to LICENSEE. If, however, such updates are developed by PRINCETON and made available for license, LICENSEE may obtain said updates from PRINCETON as part of this LICENSE. #### CI. TERMINATION

- a. If LICENSEE at any time fails to abide by the terms of this License, PRINCETON shall have the right immediately to terminate this License, and to pursue any legal or equitable remedies available.

#### CII. MISCELLANEOUS

- a. This License shall be construed in accordance with the laws of the State of California . If UCITA becomes the law of California for purposes of this License, the law of California existing prior to the effective date of UCITA shall be applicable.
- b. LICENSEE agrees that it will be responsible for any sales, use or excise taxes imposed by any governmental unit in this transaction, except income tax.
- c. Duplication or resale of the INDEX without prior authorization of PRINCETON is prohibited.
- e. Compliance with Americans with Disabilities Act.
