

AMENDMENT
III

This amendment (the "Amendment") is made by Johns Hopkins University Press, 2715 N. Charles Street, Baltimore, MD 21218 ("Licensor"), and The Regents of the University of California, a non-profit academic institution, with its principal offices at The California Digital Library, University of California Office of the President, 1111 Franklin Street, Oakland, CA 94607, USA ("Licensee"), parties to the Standard License Agreement dated May 18, 2020 (the "Agreement").

Except as set forth in this Amendment, the Agreement is unaffected and shall continue in full force and effect in accordance with its terms. If there is conflict between this amendment and the Agreement or any earlier amendment, the terms of this amendment will prevail.

Appendix A of the Agreement is amended as follows:

Additions to the Licensed Materials:

- This is a multiyear (3 years) agreement, including terms for calculating purchases for the 2026 Annual Frontlist, 2027 Annual Frontlist, and 2028 Annual Frontlist
- The Formula: Where a multiplier represents the number of units (Annual Frontlist Collection) being purchased; where an Annual Title Count in the Annual Frontlist Collection (varies annually) is multiplied by a Per title Index Rate [REDACTED]; where a discount will be applied for payment by 2/28 [REDACTED] of the purchase year.

Early Termination for Financial Hardship: The Licensee intends to fulfill its obligation to continue each year of the multi-year contract under this agreement. However, the Licensee may terminate this Agreement without penalty if sufficient content acquisitions funds are not allocated to enable the Licensee, in the exercise of its reasonable administrative discretion, to continue this Agreement. In the event of such financial circumstances, Licensee will notify Licensor of the intent to terminate the Agreement as soon as is reasonably possible, but in any case, no less than 30 days prior to the beginning of the new term, and this transaction shall terminate on the last day of the period for which payment has been made without penalty of expense to the Licensee of any kind whatsoever, except as to the portions of payments herein agreed for which funds shall have been appropriated and budgeted or otherwise available. In the event of such termination the Licensee shall maintain its perpetual right to materials licensed under the payment periods for which it has fully paid, subject to Section XII.

Payment Terms: The Licensee will pay a single invoice for the fee per year of the agreement. The order will be billed via GOBI Library Solutions.

The parties agree that scanned and/or electronically signed versions of this originally executed Amendment are acceptable in lieu of printed signed copies and are to be given full force and effect under law.
