**ADDITIONAL TERMS AND CONDITIONS**

1. This Addendum, dated 13 Oct 2004, is bound by the Terms and Conditions of the Electronic Products License Agreement between ProQuest and the Regents of the University of California executed October 20, 1999, and its Permanent On-line Access Addendum, dated June 12, 2002.
2. In addition, the following provisions are granted:
  - (a) Royalty-free, worldwide, perpetual license to PCI Fulltext Collection 4, American Drama, and 20<sup>th</sup> Century Drama, except *American Journal of Psychology*, *American Music*, and *Scottish Historical Review* which will be activated at no cost to the CDL. CDL will have access to them as long as they remain subscription-only resources.
  - (b) All future content added to these resources will be provided at no additional cost to licensee.
  - (c) Online access fees for named resources (PCI Fulltext Collection 4, American Drama, and 20<sup>th</sup> Century Drama) will be waived in perpetuity.
  - (g) ProQuest will provide usage statistics to UC at the campus level on a monthly basis for the individual ProQuest products, in compliance with International Coalition of Library Consortia (ICOLC) guidelines.


