**ADDITIONAL TERMS AND CONDITIONS**

1. This Addendum, dated 12/23/03, is bound by the Terms and Conditions of the Electronic Products License Agreement between ProQuest and the Regents of the University of California executed October 20, 1999, and its Permanent On-line Access Addendum, dated June 12, 2002.
2. In addition, the following provisions are granted:
  - (a) Royalty-free, worldwide, perpetual license to complete Digitale Bibliothek Deutscher Klassiker.
  - (b) All future content added to DBDK will be provided at no additional cost to licensee.
  - (c) CDL access to files will begin on December 1, 2003.
  - (d) Online annual access fees will be waived until 2009 (Year 6). At that time, [REDACTED] annual fee may be re-negotiated in the event that insufficient funds are appropriated and budgeted, and are not otherwise available.
