

THIS AGREEMENT is made the 21st day of May 2008

BETWEEN

- (1) IOP PUBLISHING LIMITED a company incorporated in England (registered number 467514) and having its registered office at Dirac House, Temple Back, UK - Bristol BS1 6BE, United Kingdom ("IOPP"); and
- (2) Regents of the University of California, a non-profit academic institution, with its principal offices at The California Digital Library, 415 20th Street, 4th Floor, Oakland, California 94612 USA ("the Consortium").

RECITALS

- (A) In an agreement dated 18th day of November 2002 ("the Agreement") the Consortium, for and on behalf of the Licensees, acquired electronic access to IOPP's Historic Archive (1874 – 1991) and IOPP's Recent Archive (1992 – 2001).
- (B) The Consortium now wishes, for and on behalf of the Licensees, to acquire electronic access to IOPP's Archive (as set out in Schedule 1) and the parties agree to do so on the terms of this Variation Agreement.

1. THE TERMS

- 1.1. The parties agree to vary the definition of Historic Archive as set out in Schedule 2 of this Variation Agreement.
- 1.2. In consideration of the expansion of the Archive to include the journals *Europhysics Letters* and *Physica Scripta*, the Consortium shall pay IOPP [REDACTED]
- 1.3. All terms used in this Variation Agreement shall have the same meaning as in the Agreement.
- 1.4. The Agreement shall remain in effect other than as expressly varied by this Variation Agreement.
- 1.5. This Variation Agreement shall be deemed to have commenced on 21 May 2008.
