Appendix D

Article Processing Charges

I: Business Terms and Parties' Obligations

1. Corresponding Authors who are affiliated to the institutions listed under Appendix B are granted a [REDACTED] discount on the Article Processing Charges for Karger Open Access journals (as outlined in the table below) and any additional Open Access journals that Licensor publishes during the term of the Agreement.
2. The Licensee shall ensure that Corresponding Authors shall identify themselves as being eligible to receive the above mentioned discount. Licensor shall, within the first year of the contract term (2016), use reasonable efforts to make available in its Acceptance workflow a mechanism by which Corresponding Authors can indicate their affiliation. Retrospective claims of eligibility will not be considered, i.e. no retrospective credits will be made.
