

**Addendum to License Agreement Amendment to SpringerLink Information System,
September 30, 2008, License ID: 5085**

License ID: 5085.001

This Addendum hereby incorporates the former Agreement dated January 1, 2005 made by and between the Regents of the University of California ("Licensee") and Springer Science+Business Media, Inc. ("Springer") as amended September 30, 2008. All existing terms and conditions of the Agreement are hereby ratified.

The parties desire to amend the License Agreement to provide for the purchase by Licensee of the Springer Online Journal Archive as described in Attachment 2 hereto (the "Online Journal Archive").

In consideration of the mutual promises contained herein and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

Section 1. Definitions

- 1.1 Capitalized items used in this Addendum and not defined here shall have the meanings given to them in the License Agreement unless the context clearly indicates otherwise.
- 1.2 "Licensed Materials" as defined in the License Agreement shall include the Online Journal Archive Supplement.

Section 2. Purchase of Online Journal Archive

The purchase of the Online Journal Archive Supplement by Licensee is effective as of January 12, 2009.

Section 3. Fees

- 3.1 Licensee agrees to pay a fee of [] (the "Base Price") for a one-time purchase of the Online Journal Archive Supplement as listed in Attachment 2.
- 3.2 Payment of the Base Price is due within thirty (30) days following receipt of Springer's invoice by Licensee. In the event all or any portion of the sum invoiced is not paid when due, and notwithstanding the provisions of Article 6 of the License Agreement, Springer has the right to terminate the License Agreement without notice. Springer reserves the right to charge interest on any outstanding fees due at prevailing interest rates.



Section 4. Access and Archival rights

- 4.1 Access to the Online Journal Archive will be granted through SpringerLink. In the event that Licensee is unable or unwilling to maintain current electronic subscriptions under the License Agreement with Springer, all archival rights stipulated in section XII Perpetual License and Archival Rights, and as amended September 30, 2008 will be granted.
- 4.2 As of July 2008, 62.8% of the proposed content (pages) described in Attachment 2 is accessible. As of August 2009, 95% of the proposed content (pages) described in Attachment 2 will be accessible. Springer is adding the remaining missing content to SpringerLink and will make every reasonable effort to achieve 100% fulfillment, but cannot guarantee electronic access to all issues.

Section 5. Changes in Content

- 5.1 The Online Journal Archive Supplement offering will be considered as the base collection which is purchased at the Base Price.
- 5.2 Each year the price list / offering may contain newly added and/or removed backfiles. Subsequent Online Journal Archive offerings will be announced to customers simultaneously with the regular journal price list.
- 5.3 New backfiles may be added to SpringerLink once a year and will become available at the start of a new calendar year. Licensee will be offered newly added journal backfiles for a price in line with the existing pricing model (fixed price per volume). If accepted by Licensee, such new journal backfiles will be added to the Online Journal Archive and be subject to the terms and conditions of the License Agreement.
- 5.4 If ownership of any journal included in the Online Journal Archive is sold or otherwise transferred to another party, Springer will use reasonable efforts to retain a non-exclusive copy of the previously published volumes of such journal and make them available for access by Licensee through SpringerLink.

Section 6. Amendment Incorporated, Agreement Confirmed

- 6.1 This Addendum is incorporated in its entirety into the License Agreement, and except as modified hereby, the License Agreement and all of the terms, covenants and conditions of the License Agreement are hereby ratified and confirmed and shall remain in full force and effect.

Section 7. Headings

- 7.1 Section headings in this Addendum are included for convenience of reference only and shall not constitute part of this Amendment for any other purpose.

Section 8. Counterparts

- 8.1 This AddendumAmendment may be executed in any number of separate counterparts all of which when taken together shall be deemed to constitute one and the same instrument.
