

Fifth License Agreement Amendment to SpringerLink Information System

This Amendment is entered as of the 27th day of July, 2009 by and between:

Springer Science+Business Media, LLC. 233 Spring Street New York, New York 10013-1758 ("Licensor"),

WHEREAS, the California Digital Library (CDL) on behalf of the ten (10) University of California (UC) campuses and Lawrence Livermore Lab Library, entered into an Agreement with Springer Science + Business Media, LLC, dated January 1, 2005 (the "Agreement"), last amended June 24, 2008, pursuant to which Licensor makes available to the California Digital Library (CDL) (Licensee) in electronic form certain scientific, medical and/or technical content, which may be amended from time to time; therefore

This Amendment hereby incorporates the Licensee's former Agreement dated January 2005 made by and between Licensee between Springer Science+Business Media, LLC, 233 Spring Street, New York, New York 10013-1578, USA ("Licensor") and The Regents of the University of California, a non-profit academic institution, with its principal offices at The California Digital Library, University of California Office of the President, 415 20th Street. 4th floor, Oakland, CA 94612, USA ("Licensee"). Except as herein amended, all existing terms and conditions of the Agreement are hereby ratified. To the extent that any terms and conditions of the Agreement are in conflict with or inconsistent with this Amendment, the terms of this Amendment will prevail.

NOW, THEREFORE, in consideration of the mutual promises expressed herein, and other valuable consideration the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

The Licensed Materials that are the subject of this Amendment shall consist of titles set forth in Attachment 3 of this Amendment.



ADDITIONAL PRODUCTS OR SERVICES/LICENSE:

With respect to the additional products or services to be licensed under this Amendment as identified on Attachment 3, the definition in the prior Agreement of Licensed Materials is amended to include the Additional Products, and the license granted in the prior Agreement is hereby extended to include the Additional Products, with any exceptions or other modifications noted on Attachment 3 of this document.

PAYMENT OF FEES AND TERMS:

Any changes in Fees for the Subscriber's access to and use of the Additional Products are set forth in Attachment 1.A.

The Subscriber shall pay to the Licensor the additional Fees within thirty (30) days of invoicing or as otherwise may be set forth on Attachment 1.A.

The term of this Amendment shall be for two (2) subscription years, beginning January 1, 2009 and concluding December 31, 2010.

Springer will provide invoicing in US dollar currency. The CDL-California Digital Library Consortium will remit payment in US dollars. Springer will invoice for the 2009 subscription year by August 31, 2009, and for the 2010 subscription year by August 31, 2010.
