



ACM Books Consortium License Agreement

This Agreement is made between

ACM (the Association for Computing Machinery), with its principal offices at 2 Penn Plaza, Suite 701, New York, NY 10121-0701, USA and **Morgan & Claypool Publishers**, 40 Oak View Drive, San Rafael, CA 94903, jointly referred to as ("the Publisher") and

The California Digital Library, with its principal offices at University of California, Berkeley, 250 Moffitt Library, Berkeley, CA 94720-6000 ("the Licensee").

The Licensee will be granted the non-exclusive, royalty-free, perpetual license to use the Licensed Material on the terms and conditions of this License Agreement.

1. **Authorized Users.** The following categories of users of the ACM Books (ACM BOOKS) are recognized as Authorized Users: persons affiliated with the Licensee as students, faculty, or employees, authorized persons physically present in the Licensee's library facilities. Authorized Users as defined above may be permitted by the Licensee to access the Licensed Work via proxy IP authentication through a secure connection on the Licensee's Network
2. **Authorized Uses.** Licensee and Authorized Users may make all use of the Licensed Materials as consistent with the Fair Use Provisions of United States and international law. Nothing in this License is intended to limit in any way whatsoever Licensee's or any Authorized User's rights under the Fair use provisions of US or international law.

The Licensed Materials may be used for purposes of research, education, or other non-commercial use as follows:

- (a) **Display.** Licensee and Authorized Users shall have the right to electronically display the Licensed Materials.
- (b) **Digitally Copy.** Licensee and Authorized Users may download and digitally copy a reasonable portion of the Licensed Materials.
- (c) **Print Copy.** Licensee and Authorized Users may print a reasonable portion of the Licensed Materials.
- (d) **Recover Copying Costs.** Licensee may charge a fee to cover costs of copying or printing portions of Licensed Materials for Authorized Users.
- (e) **Course Packs.** Licensee and Authorized Users may use a reasonable portion of the Licensed Materials in the preparation of Course Packs or other educational materials.
- (f) **Electronic Reserve.** Licensee and Authorized Users may use a reasonable portion of the Licensed Materials for use in connection with specific courses of instruction offered by Licensee and/or its parent institution.



- (g) Databases. If the Licensed Materials are a database, compilation, or collection of information, Authorized Users shall be permitted to extract or use information contained in the database for educational, scientific, or research purposes, including extraction and manipulation of information for the purpose of illustration, explanation, example, comment, criticism, teaching, research, or analysis.
- (h) Electronic Links. Licensee may provide electronic links to the Licensed Materials from Licensee's web page(s), and is encouraged to do so in ways that will increase the usefulness of the Licensed Materials to Authorized Users. Publisher staff will assist Licensee upon request in creating such links effectively. Licensee may make changes in the appearance of such links and/or in statements accompanying such links as reasonably requested by Publisher.
- (i) Caching. Licensee and Authorized Users may make such local digital copies of the Licensed Materials as are necessary to ensure efficient use by Authorized Users by appropriate browser or other software.
- (j) Indices. Licensee may use the Licensed Materials in connection with the preparation of or access to integrated indices to the Licensed Materials, including author, article, abstract and keyword indices.
- (k) Scholarly Sharing. Authorized Users may transmit to a third party colleague in hard copy or electronically, minimal, insubstantial amounts of the Licensed Materials for personal use or scholarly, educational, or scientific research or professional use but in no case for re-sale. For purposes of clarity, such sharing shall not exceed more than 20% of any individual title in the ACM Books series. In addition, Authorized Users, upon request to the publisher, may be granted permission to reuse with appropriate credit, figures, tables and brief excerpts from the Licensed Materials in the Authorized User's own scientific, scholarly and educational works, when the Publisher holds the rights for this material.
- (l) Interlibrary Loan. Licensee may fulfill occasional requests from other institutions, a practice commonly called Interlibrary Loan, with printed material from ACM BOOKS. Licensee agrees to fulfill such requests in compliance with Section 108 of the United States Copyright Law (17 USC 108, "Limitations on exclusive rights: Reproduction by libraries and archives") and clause 3 of the Guidelines for the Proviso of Subsection 108(g)(2) prepared by the National Commission on New Technological Uses of Copyrighted Works.
3. Unauthorized Uses of the Licensed Materials. Except as specifically provided elsewhere in this Agreement, the Licensee shall not knowingly permit anyone other than Authorized Users to use the Licensed Materials or engage in any of the following activities:
- (a) Derivative Works. Licensee's shall not modify, translate, or create derivative works of the Licensed Materials without prior written permission from the Publisher.
- (b) Copyright Infringement. Licensee's and their Authorized Users may not remove, obscure, or modify any copyright or other notices included in the Licensed Materials. All rights, title, and interest in the contents of ACM BOOKS are the recognized property of the ACM and Morgan & Claypool Publishers or their affiliates and no ownership rights, title, or interest are transferred to the Licensee as a part of this Agreement.
- (c) Commercial Use. Other than as specifically permitted in this Agreement, Licensee may not use the Licensed Materials for commercial purposes, including but not limited to the sale of the Licensed Materials or bulk reproduction of the Licensed Materials in any form.
- (d) Robotic Crawling and Downloading of Publisher's Platforms. The use of robots or intelligent agents is not permitted under the terms of this Agreement and any significant usage resulting from the use of such robots or intelligent agents will result in increased usage-based fees upon renewal of this Agreement consistent with the ACM Books pricing policy in effect at the time of renewal. Furthermore, ACM reserves the right to suspend or terminate this Agreement if systematic downloading of the ACM BOOKS is discovered.



Licensed Materials. The licensed materials covered by this License are specified in the attached addendum.

4. Access to Licensed Materials. The Publisher will deliver the Licensed Materials to the Licensee via the ACM Digital Library platform or electronic transfer by means of File Transfer Protocol or otherwise mutually agreed between the parties, in exchange for the Licensing Fees agreed. As individual books are published throughout the License Period, they will be made available to the Licensee via the access mechanism described above. Access will be managed by IP authentication and/or additional access protocols that may be mutually agreed between the parties during the term of the License. The Licensee will provide the Publisher with a complete list of current IP Addresses for all participating member institutions.
5. Perpetual Access. Upon termination of this Agreement, the Licensee may elect to continue to access the Licensed Materials from the Publisher's servers upon payment of an annual hosting fee to be specified under the "Licensing Fees" clause listed below. The hosting fee will be waived as long as the Licensee continues to License additional "Collections" as published. The Licensee shall also have the option of downloading the Licensed Materials in order to host the Licensed Materials locally on secure service, in accordance with the terms of this Agreement.
6. Mobile Access. ACM Books shall also make the Licensed Materials accessible to Authorized Users via a proprietary Mobile Application developed by ACM. Access to the Licensed Materials via this Mobile Application shall be a combination of Username / Password authentication and IP authentication tied to the Licensee's IP authenticated access ranges registered in ACM's system.
7. Licensing Fees. Licensing fees for the licensed material are specified in the attached addendum.
Hosting Fees. The license fee includes access to the content on the publisher's server for five years following completion of delivery of the content. Thereafter, the publisher may charge a hosting fee of no more than 5% of the current license price of a collection comparable in size to the hosted content. This fee will be waived as long as the Licensee continues to license future content. The Licensee shall also have the right to locally host the content in accordance with Clause 5 above with no additional fee incurred.
8. Payment Terms. Payment will be made and received by the Publisher within 30 days of receipt of an invoice from the Publisher (net 30 days).
9. Publisher Obligations. The Publisher agrees to the following during the term of the License.
 - (a) Availability of Licensed Materials. Within 30 days of receipt of this signed agreement and licensing fee, Publisher shall make the published Licensed Materials available to Licensee and Authorized Users.
 - (b) Documentation. Publisher will provide and maintain help files and other appropriate user documentation.
 - (c) Support. Publisher will offer activation or installation support, including assisting with the implementation of any Publisher software. Publisher will offer reasonable levels of continuing support to assist Licensee and Authorized Users in use of the Licensed Materials. Publisher will make its personnel available by email, phone or fax for feedback, problem-solving, or general questions.
 - (d) Training. Publisher will provide appropriate training to Licensee staff relating to the use of the Licensed Materials and any Publisher software. Publisher will provide regular system and project updates to Licensee as they become available. Publisher will provide additional training to Licensee staff made necessary by any updates or modifications to the Licensed Materials or any Publisher software.
 - (e) Quality of Service. Publisher shall use reasonable efforts to ensure that the Publisher's server or servers have sufficient capacity and rate of connectivity to provide the Licensee and its Authorized Users with a quality of service comparable to current standards in the on-line information provision industry in the Licensee's locale.
 - (f) Server Performance. Publisher shall use reasonable efforts to provide continuous service with an average of 99% up-time per month. The 1% down-time includes periodic unavailability due to maintenance of the server(s), the installation or testing of software, the loading of additional Licensed Materials as they become available, and downtime related to the failure of equipment or services outside the control of Publisher, including but not limited to public or private telecommunications services or internet nodes or



facilities. Scheduled down-time will be performed at a time to minimize inconvenience to Licensee and its Authorized Users.

(g) **Interruption of Access.** If the Licensed Materials fail to operate in conformance with the terms of this Agreement, Licensee shall immediately notify Publisher, and Publisher shall promptly use reasonable efforts to restore access to the Licensed Materials as soon as possible.

(h) **Notification of Modifications of Licensed Materials.** Licensee understands that from time to time the Licensed Materials may be added to, modified, or deleted from by Publisher and/or that portions of the Licensed Materials may migrate to other formats. Publisher shall give prompt notice of any such changes to Licensee.

(i) **Completeness of Content.** Where applicable, Publisher will inform Licensee of instances where online content differs from the print versions of the Licensed Materials. Where applicable, Publisher shall use reasonable efforts to ensure that the online content is at least as complete as print versions of the Licensed Materials, represents complete, accurate and timely replications of the corresponding content contained within the print versions of such Materials, and will cooperate with Licensee to identify and correct errors or omissions.

(j) **Compliance with Americans with Disabilities Act.** Publisher shall make efforts to comply with the Americans with Disabilities Act (ADA), by supporting assistive software or devices such as large print interfaces, voice-activated input, and alternate keyboard or pointer interfaces in a manner consistent with the Web Accessibility Initiative Web Content Accessibility Guidelines, which may be found at <http://www.w3.org/WAI/GL/#Publications>.

(k) **Withdrawal of Licensed Materials.** Publisher reserves the right to withdraw from the Licensed Materials any item or part of an item for which it no longer retains the right to publish, or which it has reasonable grounds to believe infringes copyright or is defamatory, obscene, unlawful or otherwise objectionable. Publisher shall give written notice to the Licensee of such withdrawal no later than 30 days following the removal of any item pursuant to this section. If any such withdrawal renders the Licensed Materials less useful to Licensee or its Authorized Users, Publisher shall reimburse Licensee in an amount that the withdrawal is proportional to the total Fees owed by Licensee under this Agreement.

(l) **Usage Data.** Publisher shall provide usage statistics to Licensee on demand in conformance with the COUNTER Code of Practice for e-Resources (Published April 2012), adopted and approved by the International Consortium of Library Consortia.

10. Licensee Obligations.

(a) **Provision of Notice of License Terms to Authorized Users.** Licensee shall make reasonable efforts to provide Authorized Users with appropriate notice of the terms and conditions under which access to the Licensed Materials is granted under this Agreement including, in particular, any limitations on access or use of the Licensed Materials as set forth in this Agreement.

(b) **Protection from Unauthorized Use.** Licensee shall use reasonable efforts to inform Authorized Users of the restrictions on use of the Licensed Materials and shall use all reasonable efforts to protect the Licensed Material from any use that is not permitted under this agreement. In the event of any unauthorized use of the Licensed Materials by an Authorized User, (i) Publisher may suspend or terminate such Authorized User's access to the Licensed Materials, (ii) upon notice to Licensee except in exigent circumstances, Publisher may suspend or terminate the access of the Internet Protocol ("IP") address(es) from which such unauthorized use occurred, and/or (iii) Licensee may terminate such Authorized User's access to the Licensed Materials upon Publisher's request.

11. Mutual Obligations.

(a) **Confidentiality of User Data.** Publisher and Licensee agree to maintain the confidentiality of any data relating to the usage of the Licensed Materials by Licensee and its Authorized Users. Such data may be used solely for purposes directly related to the Licensed Materials and may only be provided to third parties in aggregate form. Raw usage data, including but not limited to information relating to the identity of specific users and/or uses, shall not be provided to any third party, unless such disclosure is reasonably necessary for subpoena, court order or other legal proceeding.



(b) Implementation of Developing Security Protocols. Licensee and Publisher shall cooperate in the implementation of security and control protocols and procedures as they are developed during the term of this Agreement.

12. Archival Rights. Upon request of the Licensee, Licensee may receive from the Publisher and/or create one (1) copy of the entire set of Licensed Materials to be maintained as a backup or archival copy during the term of this Agreement or as required to exercise Licensee's rights under the "Perpetual Access" clause of this Agreement. Upon request, Publisher will provide the Authorized Institutions and their Authorized Users with access to the full text of the Licensed Material which was published and paid for by the Licensee during the term of this Agreement, either through CLOCKSS, Portico, or by supplying the electronic files in a medium and format mutually agreed between the parties to the Authorized Institutions without charge. The full text of the electronic files may not be resold at any time; this remains in effect in perpetuity. Continuing archival access is subject to the terms and conditions of use of this License.
13. Term and Termination. The term of this Agreement will be for a 5 year period following the completion of delivery of the Licensed Materials.
 - (a) Early Termination. In the event that either party believes that the other materially has breached any obligations under this Agreement, or if Publisher believes that Licensee has exceeded the scope of the License, such party shall so notify the breaching party in writing. The breaching party shall have 60 days from the receipt of notice to cure the alleged breach and to notify the non-breaching party in writing that cure has been effected. If the breach is not cured within the 60 day period the non-breaching party shall have the right to terminate the Agreement without further notice.
 - (b) Termination for Cause. Upon Termination of this Agreement for cause, online access to the Licensed Materials by Licensee and Authorized Users shall be terminated. Authorized copies of Licensed Materials may be retained by Licensee or Authorized Users and used subject to the terms of this Agreement.
14. License Renewal. This Agreement shall be renewable, based on the Licensee's agreement to purchase additional ACM Books Collections in exchange for additional mutually agreed Licensing Fees.
15. Amendments. All amendments and modifications to this Agreement shall be made in writing and be signed by duly authorized representatives of both parties.
16. Warranties. Subject to the Limitations set forth elsewhere in this Agreement: Publisher warrants that it has the right to license the rights granted under this Agreement to use Licensed Materials, that it has obtained any and all necessary permissions from third parties to license the Licensed Materials, and that use of the Licensed Materials by Authorized Users in accordance with the terms of this Agreement shall not infringe the copyright of any third party. The Publisher shall indemnify and hold Licensee and Authorized Users harmless for any losses, claims, damages, awards, penalties, or injuries incurred, including reasonable attorney's fees, which arise from any claim by any third party of an alleged infringement of copyright or any other property right arising out of the use of the Licensed Materials by the Licensee or any Authorized User in accordance with the terms of this Agreement. This indemnity shall survive the termination of this agreement. **NO LIMITATION OF LIABILITY SET FORTH ELSEWHERE IN THIS AGREEMENT IS APPLICABLE TO THIS INDEMNIFICATION.**

Notwithstanding anything else in this Agreement:

- (a) Neither party shall be liable for any indirect, special, incidental, punitive or consequential damages, including but not limited to loss of data, business interruption, or loss of profits, arising out of the use of or the inability to use the Licensed Materials.
- (b) Publisher makes no representation or warranty, and expressly disclaims any liability with respect to the content of any Licensed Materials, including but not limited to errors or omissions contained therein, libel,



infringement of rights of publicity, privacy, trademark rights, moral rights, or the disclosure of confidential information.

(c) Except for the express warranties stated herein, the Licensed Materials are provided on an "as is" basis, and Publisher disclaims any and all other warranties, conditions, or representations (express, implied, oral or written), relating to the Licensed Materials or any part thereof, including, without limitation, any and all implied warranties of quality, performance, merchantability or fitness for a particular purpose.

(d) Publisher makes no warranties respecting any harm that may be caused by the transmission of a computer virus, worm, time bomb, logic bomb or other such computer program. Publisher further expressly disclaims any warranty or representation to Authorized Users, or to any third party.

- 17. Indemnification. Each party shall indemnify and hold the other harmless for any losses, claims, damages, awards, penalties, or injuries incurred by any third party, including reasonable attorney's fees, which arise from any alleged breach of such indemnifying party's representations and warranties made under this Agreement, provided that the indemnifying party is promptly notified of any such claims. The indemnifying party shall have the sole right to defend such claims at its own expense. The other party shall provide, at the indemnifying party's expense, such assistance in investigating and defending such claims as the indemnifying party may reasonably request. This indemnity shall survive the termination of this Agreement.
18. Governing Law. The terms and conditions of this Agreement are governed by California law. All disputes arising out of or in connection with this Agreement shall be exclusively submitted to arbitration in accordance with the Arbitration Rules of the State of California.
19. Assignment. This Agreement may not be assigned by either party to any other person or organization, nor may either party sub-contract any of its obligations, without the prior written consent of the other party.
