

APPENDIX C – JOURNAL BACKFILES – Amendment 1

California Digital Library

Licensed Electronic Journal Backfiles are the electronic (online) editions of Wiley journal content published in years designated as part of a backfile package to which the Licensee has access under this License, including tables of content, abstracts, full text and illustrations and any additional electronic journal content not included in the print versions of the journals.

Perpetual Access:

Wiley will provide the Licensee with perpetual access to the full text of the Licensed Electronic Journal Backfiles where Wiley has the rights to deliver this. Wiley, in its discretion, will either continue online access to the same material on Wiley's server or provide an archival copy in the electronic medium selected by Wiley, at a reasonable cost-based fee.

Pricing
