ADDENDUM TO LIBRARY LICENSE AGREEMENT

This Addendum (the "Addendum") to the Library License Agreement dated January 1, 2013 (the "Agreement") is effective April 6, 2017 (the "Addendum Effective Date") and is by and between Taylor & Francis Group, LLC, a state of Delaware limited liability company having its principal place of business at 6000 Broken Sound Parkway NW, Suite 300, Boca Raton, FL 33487 (the "Licensor"), and The Regents of the University of California, a non-profit academic institution, with its principal offices at The California Digital Library (CDL), University of California, Office of the President, 415 20th Street, 4th Floor, Oakland, CA 94612, USA (the "Licensee").

The Licensee agreed to a 3-year agreement for the purchase of all 2017, 2018, and 2019 publication year content on the CRCnetBASE eBook platform (all title output for these years, all subject areas) with an annual price increase cap of [REDACTED]

The agreed purchase price of the 2017 CRCnetBASE content is [REDACTED]

Licensee will be invoiced immediately with payment due to Licensor within sixty (60) days of invoice.

The purchase price of all 2018 CRCnetBASE content shall be [REDACTED] and Licensee shall be invoiced for this purchase by January 7, 2018 with payment due to Licensor within sixty (60) days of invoice.

The purchase price of 2019 content shall be [REDACTED] and Licensee shall be invoiced by January 7, 2019 with payment due to Licensor within sixty (60) days of invoice.

No other fees will be charged.

All CRCnetBASE 2017, 2018, and 2019 publication year titles, as they are published and added to the CRCnetBASE platform.

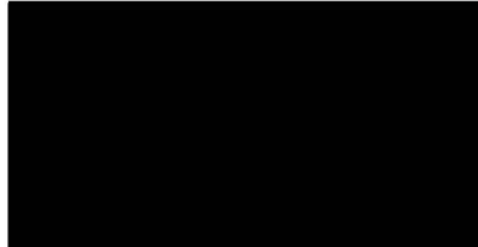
