



## ADDENDUM TO LIBRARY LICENSE AGREEMENT

This Addendum (the “Addendum”) references the License Agreement (the “Agreement”) effective January 1, 2013 between Taylor & Francis Group, having its principal place of business at 6000 Broken Sound Parkway NW, Suite 300, Boca Raton, FL 33487 (the “Licensor”), and the Regents of the University of California on behalf of the California Digital Library (CDL), University of California, Office of the President, having its principal place of business at 1111 Franklin Street , Oakland, CA 94607 (the “Licensee”).

This Addendum is effective January 27, 2021 (the “Addendum Effective Date”) and amends the Agreement as follows:

The Licensee has agreed to the purchase of perpetual access to all CRCnetBASE (STMnetBASE) titles, plus any DRM-free CRC Press eBook titles not otherwise included in a NetBASE collection, from the content year 2021. Content year is defined by the year the content was first published (whether in print or electronically). It represents the actual age of the content. A few titles continue to publish where the publication year is later than the content year; such titles will continue to be added to Licensee’s entitlements.

### PURCHASE PRICE

The agreed purchase price for this 2021 CRC content is USD \$ [REDACTED].

Licensee will be invoiced immediately with payment due within sixty (60) days of invoice. No other fees will be charged.

### MATERIALS

All 2021 content year CRCnetBASE (STMnetBASE) eBook titles plus any DRM-free 2021 content year CRC Press eBook not otherwise included in a NetBASE collection.
