AMENDMENT TO LICENSE AGREEMENT

This Amendment is entered into as of April 1, 2026 by and between University of California ("Licensee"), a non-profit academic institution, with its principal offices at The California Digital Library, University of California Office of the President, 415 20th Street, 4th floor, Oakland, CA94612, USA, and Airiti Inc. ("Airiti"), 18th Floor, No.80, Sec. 1, Chenggong Rd., Yonghe District, New Taipei City, 23452, Taiwan.

I. Additional Provisions

WHEREAS Licensee and Airiti Inc. previously entered into an agreement dated June 1, 2019 ("the Agreement") concerning the provision of eBook services.

1. Licensee and Airiti Inc. agree that, with respect to the eBook titles covered by this Agreement, the parties shall conduct an annual verification of copyright and licensing rights. Airiti Inc. shall conduct a two-week rights verification process in early December each year to confirm the list of titles available for use in the following year. Airiti Inc. shall also provide the Licensee with a list of titles for which the applicable licensing period has expired for reference. Upon confirmation by both parties, Airiti Inc. shall remove such titles from the Licensed Materials by the end of December.
2. The Parties agree to add the University of California, Davis to the list of 'Campuses of the University of California' as set forth in Appendix A.

3. Users within the IP range of the University of California, Davis shall be entitled to access both purchased and non-purchased titles within 'the PDA pilot with Airiti', in accordance with the terms and conditions set forth in this Agreement.

 4. The Parties agree to the following amendments to the Business Terms in Appendix B regarding the University of California, Davis:
 - One-time Access Expansion Fee: [REDACTED] (payable by Licensee).
 - Annual PDA Deposit: Adjusted from [REDACTED] payable by Licensee).
 - For any further campuses added hereafter, the Licensee will pay a one-time Access Expansion Fee of [REDACTED] per campus, and the annual PDA deposit will be increased by an additional [REDACTED] per campus.

 5. Except as expressly amended or modified herein, all other terms and conditions of the Agreement shall remain unchanged and in full force and effect, and are hereby ratified and confirmed.
