

**Society for Industrial and Applied Mathematics  
Online Journals Subscription Agreement  
Addendum One**

THIS ADDENDUM is made on the 25<sup>th</sup> day of October 2004.

BETWEEN:

**Licensor:** Society for Industrial and Applied Mathematics ("SIAM"), 3600 University City Science Center, Philadelphia, PA 19104 USA ; and

**Licensee:** University of California San Diego ("Licensee"), 9500 Gilman Drive, La Jolla, CA 92093 USA

This is an Addendum to the **Society for Industrial and Applied Mathematics Online Journals Subscription Agreement** ("the License Agreement") signed by the Licensee March 27, 2002 and made between SIAM and the Licensee;

From the Date hereof the License Agreement shall be amended as follows:

1. The Licensed Material shall include, effective 1/1/05, in addition to that specified in the License Agreement, unlimited, perpetual access to the following:

LOCUS: SIAM Online Journal Archive (1952-1996)

for all 10 campuses and the Office of the President of the University of California.

2. The License Agreement shall remain in full force and effect, and the terms of the License Agreement shall apply to the Licensed Material set out herein as if it were included in the License Agreement.

3. SIAM agrees to waive the annual access fee for LOCUS: SIAM Online Journal Archive while any University of California campus maintains electronic access to current SIAM online journals. In the event that all campuses terminate access to the current SIAM online journals, a mutually agreed upon annual access fee will be paid for continued electronic access to LOCUS archive.

4. Upon request, the University of California may receive from SIAM one copy of LOCUS: SIAM Online Journal Archive to be maintained as a backup or archival copy during the term of the Agreement, or as required, to exercise the University's perpetual rights, above. Conditions and terms of use will be exercised pursuant to the terms of the Agreement and subsequent amendments.
